**NOTICE TO THE NOMINEES / LEGAL HEIRS OF REGULAR SHARE HOLDERS**  
**OF THE BANK, IN CASE OF DEATH CLAIM.**

It is hereby informed that, in the event of the death of a Member / Depositor of the Bank, the nominee(s) or legal heir(s) may submit the necessary records with respect to shares / deposits of the deceased Member / Depositor as given below:

**A. In Case of Nominee :**

Where a valid nomination has been registered in the records of the Bank, the nominee may submit the following documents:

1. Request Letter from the nominee.
2. Death Certificate of the deceased Member / Depositor (original for verification).
3. Identity and Address Proof of the nominee (Aadhaar / PAN / other valid document).
4. Recent Photograph of the nominee.
5. Original Share Certificate to be produced for verification & photo copy to be submitted.

Please note that in the event of settlement of claim by the Bank, if & when permitted by the Competent Authorities, the nominee may also have to submit an Indemnity Bond on Rs.500/- stamp paper, duly Notarized.

**B. In Case of Legal Heir - LH (Where Nomination is Not Available / Nominee is Deceased)**

In cases where no nomination has been registered with the Bank or where the nominee is deceased, the legal heir(s) of the deceased Member / Depositor may submit the following documents:

1. Request letter from the legal heir(s).
2. In case, one of the legal heir is being authorized to represent the others, a suitable letter of Authorization by all the other LH.
3. Death Certificate of the deceased Member / Depositor (original for verification).
4. Death Certificate of the Nominee, if applicable (original for verification).
5. Legal Heir Certificate / Family Tree Certificate issued by the Tahashildar / Competent Authority.
6. Identity and Address Proof (PAN & Aadhaar) of all legal heir(s).
7. Affidavit, duly notarized confirming the list of legal heirs.
8. Original Share Certificate to be produced for verification & photo copy to be submitted.




